Dear Parent/Guardian,

Oakwood Elementary students participating in the Title I, Part A program, and their families, agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement as well as describes how school and parents will build and develop a partnership that will help children achieve the State's high standards.

To understand how working together can benefit your child, it is first important to understand our district's and school's goals for student academic achievement.

Hall County School System Goals:

By the end of FY22, the percentage of students in each subgroup moving into the "Proficient" and "Distinguished" levels of performance on the Georgia Milestones Assessments will increase by 2% in the "Proficient" and "Distinguished" levels of performance.

By the end of FY23 (with FY22 being the baseline year), the percentage of students in each subgroup meeting "Proficient" levels of performance on local assessments (Elementary - MAP/Beacon, Middle/High – Common Benchmark Assessments) will increase by 2%.

Increase the percentage of referred students who access school-based mental health services by 2% each year (with FY21 being the baseline year).

Oakwood Elementary Goals:

By the end of the 2021-2022 school year, there will be a 5% increase in the number of students reading on or above grade level as measured by: EOG midpoints for 3rd-5th Grade level reading Assessments (Map, F&P).

By the end of the 2021-2022 school year, there will be a 5% increase in the number of students performing on or above grade level in mathematics as measured by: EOG mid points for 3rd-5th Grade level Assessment (Map).

By the end of the 2021-2022 school year, 100% of students and staff members at Oakwood Elementary will participate in character education and activities to increase resilience.

School Responsibilities:

Oakwood Elementary will provide high quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards by:

- Providing a safe and caring learning environment that promotes high expectations and accountability for all.
- Assessing students regularly on their progress.
- Providing instruction in the content areas by utilizing vocabulary, Readers/Writers Workshop across all grade levels, comprehension strategies, writing summaries across all grade levels, numeration and computation, number sense and estimation, geometry and measurement, science, and social studies.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.

Parents may set up a meeting at any time with their child's teacher or the administration to discuss their child's progress. OES will meet annually in the fall to discuss the contents of this compact. Parent conferences provide a time to revisit the compact.

3. Provide parents with frequent reports on their children's progress.

Use of the agenda establishes a means of daily communication with the parents. Parents are also encouraged to use the agendas to ask questions and inform the teacher of things that may be beneficial to the child's education. In addition, we have access to contact parents through the student information system, Infinite Campus. Progress reports are sent home every 9 weeks.

4. Provide parents reasonable access to staff.

Oakwood host an Open House in the Fall. This meeting serves as an opportunity for the parents to meet the teachers. The teachers explain the expectation for the students and discuss with parents how they can assist with the education of their children. Oakwood works very hard to establish an open door policy for parents to access the staff. Our school is very open and parents know that the teachers are available upon request. Teachers will be available to meet with parents before school, after school, and during planning times. We maintain daily contact with our parents through the use of student agendas, newsletters, e-mails, phone calls, text messages, webpages and work folders. Parents are also invited in once a year to participate in their child's Student Led Conference.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities as follows:

In order to guarantee student success, partnerships among schools and parents are vital. Parents participate on school committees such as the PTO and as Event Volunteers. At Oakwood Elementary, we recognize that parents are their children's primary teachers and their support is critical in our efforts to provide a quality education to the children at our school. Oakwood Elementary shares responsibility with parents/guardians for high student performance by developing a school-parent-student compact and the Parent Involvement Policy. Parents, students, and staff review the compact and policy each year.

Parent Responsibilities:

We, as parents, will:

- inspire, motivate, and promote leadership in the home;
- provide adequate food and rest so my child is ready to learn;
- encourage my child to read at home;
- see that my child attends school regularly and on time;
- provide a home environment that encourages my child to learn;
- talk with my child about his/her school day activities;
